Limited One-Year Warranty

The Schaeffer Manufacturing Company (Schaeffer) warrants to this customer that any Schaeffer product sold to the customer in this Order will be free from defects in materials and workmanship, will be in accordance with Schaeffer's published specification, if any, for that product, and will be in accordance with Schaeffer's published affirmations of fact, if any, for that product for a period of one (1) year from the date of purchase. Schaeffer will remedy any such defect or variation in the product sold by it by, at its option, replacing said product or refunding the purchase price of said product provided the customer delivers said product to Schaeffer with all freight prepaid and with written notification of the specific defect or variation within 1 and ½ years from the date of purchase.

This warranty does not extend to any Schaeffer product sold to the customer in this Order which has been subjected to misuse, neglect, accident, improper installation, used in manner for which the product has not been designed or used in violation of instructions, if any, furnished by Schaeffer.

ALL WARRANTIES IMPLIED BY LAW, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS, ARE HEREBY DISCLAIMED. THE EXPRESS WARRANTIES AND THE REMEDIES CONTAINED HEREIN: ARE MADE SOLELY TO THE FIRST PURCHASER FOR BENEFICIAL USE (THE CUSTOMER); ARE THE SOLE AND EXCLUSIVE WARRANTIES AND REMEDIES; ARE IN LIEU OF ALL OTHER WARRANTIES, GUARANTIES, AGREEMENTS OR OTHER LIABILITIES, EITHER EXPRESS OR IMPLIED; AND ARE IN LIEU OF ALL OTHER REMEDIES FOR BREACH OF WARRANTY OR ANY OTHER LIABILITY, INCLUDING ANY ALLEGED NEGLIGENCE OF SCHAEFFER. IN NO EVENT SHALL SCHAEFFER BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES AND IN NO EVENT SHALL SCHAEFFER BE LIABLE FOR ANY DAMAGES WHICH EXCEED THE PURCHASE PRICE OF THE PRODUCT SOLD.

No agent, employee or representative of Schaeffer has any authority to bind Schaeffer to any other affirmation, representation or warranty concerning the product sold under this order to change, modify, or extend the terms hereof in any manner whatsoever.

If it is held by a court of competent jurisdiction that there is an irreconcilable conflict between the express warranties set forth herein and any warranties implied by law, it is declared by the customer and Schaeffer that the warranty intended to prevail are the express warranties herein along with the limitation of warranty and the limitation of remedies and damages herein.

The aforesaid limited on year warranty is acknowledged by Schaeffer and by the customer to be an integral part of this Order and bargain.
