Section 4. First aid measures

Description of necessary first aid measures

Eye contact

: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 20 minutes. Get medical attention.

Inhalation

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. For non-emergency personnel

Methods and materials for containment and cleaning up

Small spill

Large spill

Prevent entry into sewers, water courses, basements or confined areas. Section 7. Handling and storage

Precautions for safe handling

Protective measures
